The proceeds of sale of the Series 2023 Bond will be loaned to the Agency and will be used to finance or reimburse all or a portion of the costs of (i) acquiring, constructing, and equipping certain improvements and additions to that certain healthcare facility located at 1491 Parkway Drive, Blackfoot, Idaho 83221, in the approximate amount of \$1,600,000 (the "Blackfoot Project"), (ii) acquiring, constructing, and equipping a new healthcare facility to be located in Rigby, Idaho at Lot 4 in Bird Park Division No. 1, Jefferson County, Idaho, as shown on the plat recorded November 1, 2021, as Instrument No. 468345, in the approximate amount of \$2,000,000 (the "Rigby Project"), (iii) acquiring, constructing, and equipping a new early childhood development facility to be located at 1122 Washington Street S., Twin Falls, Idaho, 83301, in the approximate amount of \$4,000,000 (the "Twin Falls Project"), and (iv) acquiring, constructing, and equipping certain improvements and additions to the Agency's headquarters and early childhood development facilities located at 317 Happy Day Blvd., Caldwell, Idaho 83607, in the approximate amount of \$1,400,000 (the "Caldwell Project" and together with the Blackfoot Project, Rigby Project, and Twin Falls Project, collectively, the "Project"), and (v) issuing the Series 2023 Bond. The Project is or will be owned and operated by the Agency.

The hearing will take place on January 19, 2023 at 10:00 A.M. MST, and will be held at the Idaho Health Facilities Authority, located at 1087 W River St., Ste. 250, Boise, ID 83702.
